THIS PAGE IS FOR EYEBROWS, PLEASE SCROLL DOWN FOR EYELINER

- **6 weeks:** No chemical/Laser peels.
- **30 days:** No Retinoid products/Retin-a/Tretinoin.
- **14 days: Halt all skincare products** with acids/active ingredients (Vitamin C, Lactic Acid, Salicylic Acid, etc. Hyaluronic Acid is okay!). If you have questions about your skincare products, please email Lammergeier Studio with photos of the ingredient lists. Please **protect your skin from the sun**, ensuring you do not have sun burns leading up to your appointment. **Do not get botox.**
- **7 days:** Stop tinting your eyebrows.
- **48 hours:** Do not take NSAIDs (advil/ibuprofen, etc) or fish oil. (Please consult your physician if this is an issue). Do not pluck or wax your eyebrows. Make sure you do not have pimple or blemishes in the brow area.
- **24 hours:** Do not drink alcohol,
- **Day of appointment:** Avoid caffeine (cup of coffee is okay, just don't over do it!), avoid marijuana (can cause twitching), avoid clothing (especially headwear) that you do not want to risk getting stained by ink. Always eat a meal before your tattoo appointment.
- Do not bring children to your appointment. If children are brought, you will need to reschedule and will be charged the full cost of the appointment. (Please refer to the Booking Fee Terms).
- Please arrive at the specified time (not early, not late!)
- If you start to have cold symptoms, please let Lammergeier Studio know immediately so we can reschedule. (Please refer to Booking Fee Terms).

- **3 Months:** No lash grow serums (6 months for Latisse) or Eyelash lifts/tints
- **60 days:** No retinol eye cream
- **30 days:** Keep active skincare ingredients away from eye area
- **14 days:** Do not tint lashes and stop wearing strip lashes. Please ensure your eye area has been protected from the sun.
- **7 days:** Remove eyelash extensions. Halt the use of strip lashes. Do not use waterproof mascara or eyeliner
- **48 hours:** Do not take NSAIDs (advil/ibuprofen, etc) or fish oil. (Please consult your physician if this is an issue).
- **24 hours:** Do not drink alcohol, clean eye makeuo iff and do not reapply before your appointment.
- **Day of appointment:** Do not wear contact lenses (they may be reapplied no less than 24 hours after), do not smoke marijuana (can cause twitching), avoid caffeine, avoid clothing (especially headwear) that you do not want to risk getting stained by ink. Always eat a meal before your tattoo appointment.
- Do not bring children to your appointment. If children are brought, you will need to reschedule and will be charged the full cost of the appointment. (Please refer to the Booking Fee Terms).
- Please arrive at the specified time (not early, not late!)
- If you start to have cold symptoms, please let Lammergeier Studio know immediately so we can reschedule. (Please refer to Booking Fee Terms).
